**AN ORDINANCE OF THE CITY OF SMITHS STATION, ALABAMA, TO AMEND ORDINANCE 2020-172, ESTABLISH STREET NAMES ON THE ROADS, ROADWAYS, STREETS, AND BYWAYS WITHIN THE CITY LIMITS OF SMITHS STATION, ALABAMA.**

**WHEREAS**, The Chairman of the Road Name Change Committee has made a recommendation to amend and finalize the list of previously approved Road Names.




**SECTION 1.** The City approves, endorses all provisions listed in "Exhibit "A" as listed;




