A RESOLUTION OF THE CITY OF SMITHS STATION, ALABAMA, APPROVING ANNEXATION OF CERTAIN PROPERTIES INTO THE MUNICIPAL LIMITS OF THE CITY OF SMITHS STATION, ALABAMA.

WHEREAS, it is the opinion of the City Council of the City of Smiths Station, Alabama that the public health and public good require that certain territory shall be brought within and annexed to the corporate limits of the City of Smiths Station, Alabama; and,

WHEREAS, the City Council deems it wise, expedient and economical to apply for the annexation of said territory to the corporate limits of the City of Smiths Station, Alabama by passage of a Local Law in the Legislature of Alabama; and,

WHEREAS, the City Council has caused to be prepared a Bill for introduction in the Legislature of Alabama, accurately describing said territory, to accomplish the annexation of said property to the corporate limits of the City of Smiths Station, Alabama;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SMITHS STATION, ALABAMA, as follows:

(1) That the Mayor of the City of Smiths Station, Alabama be and is hereby directed to cause the following notice to be published in a newspaper of general circulation published in Lee County, Alabama once each week for four consecutive weeks, commencing on January 10, 2018, to wit:

Notice is hereby given pursuant to Section 106 as amended by Amendment 341 to the Constitution of Alabama 1901 that a bill substantially as follows will be introduced in the 2018 Session of the Legislature of Alabama and application for its passage and enactment will be made:

A Bill To Be Entitled An Act

To alter or rearrange the boundary lines of the City of Smiths Station, Lee County, Alabama, so as to include within the corporate limits of said City all territory now within such corporate limits and also certain other territory contiguous thereto, in Smiths Station, Lee County, Alabama.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. That the boundary lines of the City of Smiths Station, Lee County, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Smiths Station, and in addition thereto the following described territory, to-wit:

Section 2. A map showing the territory proposed to be annexed is on file in the office of the judge of probate in Lee County. This map is open to public inspection.
