At 6:25 the Regular Meeting reconvened. City Clerk Johnston conducted roll call. All members were present.

Alice Spengler registered to address the Council during the Public Comments portion of the Agenda. The topics she addressed the Council on were, (1) Lack of signage at the polling place for the August 25, 2020 Municipal Elections, (2) Desiring additional information during the introduction of Ordinances and Resolutions, (3) Questioning the usage of the Council's authority to Suspend the Rules of Ordinances and Resolutions.

Mr. and Mrs. A.J. McCurry registered to address the Council during the Public Comments portion of the Agenda. The topics they both addressed the Council were residents close to their house burning yard debris and trash within the City Limits and the affects the burning has on them, other family members and their personal property.

Financial Officer Shelby Branton presented the Financial Statement for the General Fund Budget for the month ending July 31, 2020. Council Member Key made a motion to accept the budget as presented. Council Member Jackson seconded the motion.

Mayor Copeland requested a motion to adjourn. Having no further business, Council Member Jackson made the motion to adjourn. Council Member Stringer seconded the motion. The motion passed and at 6:42 P.M. the meeting was adjourned.
