At 5:31 Mayor Copeland requested and made a motion the Council convene into Executive Session as permitted in Section 36-25A-7(a)(1), Code of Alabama, 1975 for 5-10 minutes. Council Member Cooley seconded the motion. The roll call vote was as follows: Yeas, Council Members Stringer, Jackson, Moody, Cooley, Key, Mayor Copeland. Nays, None. The motion passed.

At 5:43 the Work Session reconvened. City Clerk Johnston conducted roll call. All members were present. General municipal business was discussed, and the agenda was reviewed. No business was conducted. The Work Session was adjourned at 5:56 P.M.
