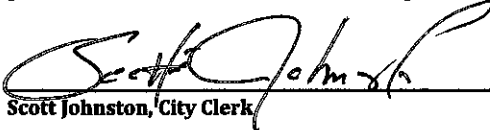
City Clerk Johnston introduced Resolution 2020-401; Authorize the Mayor to Manage Financial Accounts.

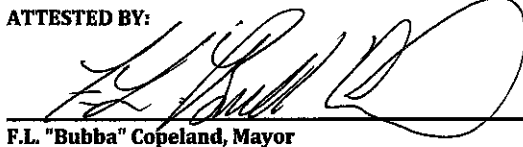
Mayor Copeland announced the following City Council Committees and the Committee Members.
