WHEREAS, The City of Smiths Station is obligated to provide an effective method by which to manage the Pavilion, ancillary forms of activities as well the City's resources, and to ensure that it is used for the appropriate activities;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SMITHS STATION, ALABAMA. AS FOLLOWS;

SECTION 1. The City approves, endorses all provisions listed in "Exhibit "A", "B", "C", "D" as listed;

- 1. "Pavilion Facility Rental Application General Information" (Exhibit "A"),
- 2. "Facility Rental Liability Hold Harmless Agreement" (Exhibit "B"),
- 3. "Pavilion Facility Rental Application" (Exhibit "C"),
- 4. "Pavilion Facility Rental Payment Form" (Exhibit "D").

SECTION 2. The City <u>requires all interested persons</u> to complete, in their entirety, the form(s) which apply regarding the application and/or agreement.

SECTION 3. All funds generated through activities of the City of Smiths Station Parks & Recreation Department shall be received and receipted at Smiths Station City Hall.

REPEALER CLAUSE: All resolutions, or parts or resolutions heretofore adopted by the City Council of the City of Smiths Station, Alabama that are inconsistent with the provisions of this resolution are hereby repealed.
