RESOLUTION 2020-395

A RESOLUTION FOR THE CITY OF SMITHS STATION, ALABAMA TO AMEND THE GENERAL FUND BUDGET BY DEPARTMENTS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019 AND ENDING SEPTEMBER 30, 2020.

WHEREAS, the Mayor and the Finance Committee held budget meetings to consider all the needs concerning funding for the General Fund Budget by Departments and made a recommendation to the City Council; and

WHEREAS, the City Council approved and adopted Resolution 2019-331; Approving and Adopting the General Fund Budget for Fiscal Year 2019-2020, and;

WHEREAS, on June 1, 2020, through a **Contractual Transfer Agreement** with Lee County Alabama, the City obtained ownership and maintenance responsibilities for all streets, roads, roadways, and bridges within the City Limits of the City of Smiths Station; and,

WHEREAS, within the Transfer Agreement, Statement of Agreement, Paragraph 1 states the compensation from Lee County to the City of Smiths Station for being relieved of the burden of the control, management, supervision, maintenance, and improvement of and all County roads within the corporate limits of the City of Smiths Station in the amount of Two Million Five Hundred Thousand (\$2,500,000.00) Dollars to be paid as follows: Two Hundred Fifty Thousand (\$250,000.00) Dollars at the execution of the Agreement, and Two Hundred Fifty Thousand (\$250,000.00) Dollars shall be paid on the same date of each subsequent year for Nine (9) consecutive years; and,

WHEREAS, the City did not anticipate, nor take into account, the additional revenues or expenditures relating to the Contractual Transfer Agreement; and,

WHEREAS, on August 27, 2020 the City Council Approved and Adopted Ordinance 2009-065.01: Establish Public Works Department; and,

WHEREAS, the City Council has a fiduciary responsibility to balance the General Fund Budget; and,

NOW THEREFORE, be it Resolved by the City Council of the City of Smiths Station, Alabama, at a regular meeting, duly assembled, a quorum being present; that by the adoption of this Resolution the City Council does hereby Amend the General Fund Budget for Fiscal Year 2019-2020 to appropriate the sums and amounts as set out in Exhibit A.
