Code of Alabama 1975, as amended the municipal governing body of the City of Smiths Station met on this the 13<sup>th</sup> Day of October 2020, at 12:00 Noon P.M., a quorum thereof being present, and has canvassed the returns, and has ascertained and determined the number of votes received by each candidate, and


