**RATES & CHARGES FOR SOLID WASTE COLLECTION<sup>1</sup>**

- Solid Waste Service statements are billed on a quarterly basis (January, April, July, October).
- Solid Waste Service customers are required to pay a set-up fee of Thirty Dollars (\$30.00) per unit.
- Solid Waste Service rates are currently Sixty-One Dollars and Twenty Cents (\$69.00 per quarter) (\$23.00 per month).
- Additional Canisters are available for an additional \$36.00 per quarter (\$12.00 per month).

Such payment shall be due by the first day of each quarter and such payment shall be delinquent after 15 days and a late fee of 15% shall be assessed. After 45 days from the due date, a late fee of an additional 15% shall be assessed and the account and services shall be suspended. Once an account is suspended, the owner shall bring the account current and shall pay a new set-up fee prior services being reinstated. After Six months of an account becoming inactive due to the physical property becoming vacant, the owner of the property shall pay a new set-up fee prior to services being reinstated.

I, \_\_\_\_\_, owner of the above physical property understand that I am responsible for the Solid Waste fees for this account. It is also my responsibility as the owner to inform the City of Smiths Station, Alabama when this physical property becomes vacant. I understand and agree to all terms and provisions of this application. I further understand failure to receive the City of Smiths Station Solid Waste Statement shall not absolve me of the responsibility of payment on time. The City does not provide provisions for tenants and or renters to acquire responsibility of solid waste accounts.
